8 School Improvement Plans

Minutes:

-Mrs. Amanda Pyle, Elementary School principal, explained the importance of understanding the difference between ISTEP scoring and School Report Card scoring. ISTEP only has 3 proficiency levels for its scores, while the School Report Card system has many levels. Therefore, while ISTEP scores may not reach the next proficiency level, the School Report Card system can indicate more clearly for school administrators the direction in which student proficiency is going. In the case of EH, there has been a lot of positive growth in the right direction. The Elementary School will continue to build on this growth in the daily classroom as it prepares for the replacement of ISTEP with ILEARN testing.

-Mr. Dave Pfaff, Middle School & High School principal, shared that both the Middle School and High School have also seen positive growth in test scores, particularly in the area of English/Language Arts. EH Math scores have consistently been strong, and the English/Language Arts scores are now very good as well. Mr. Pfaff credits this improvement to the effort of the teachers in all subject areas to push English skills in their classrooms and coursework. Moving forward, the Middle School and High School will also work to continue this improvement as well as prepare for the Graduation Pathways system that will be in place in a few years. Mr. Pfaff shared how strong EH currently is in this, in that one of the scores is a College & Career Readiness score which indicates the percentage of students who earn college credits while in high school. The state goal for this is 25% of students. The Eastern Hancock score is almost triple this percentage.

-Mr. Petry recognized Mr. Pfaff, Mrs. Pyle and all the administrators in the hard work that goes into assessing these various scores and utilizing them to create an improvement plan for our students.
