Mr. Younts spoke on the need of updating our wastewater/sewage plant.

7 School Lunch Pricing for 2016-2017

Mr. Johnson moved and Mr. Jackson seconded a motion to increase school lunches by \$0.10 to comply with federal legislation, called the *Healthy, Hunger-Free Kids Act of 2010*.

Elementary Student Lunch - \$2.65

Middle/High School Student Lunch - \$2.75

According to the INDOE, the USDA will not publish the reimbursement rates for SY2016-2017 until July. Therefore, we cannot accurately determine our adult/guest meal prices or our breakfast prices. These prices are to be based on our reimbursement rate, the extra six cents certification amount, the per-meal value of the USDA donated foods, and preparation costs involved.

Page 7 **Book Rental**

 Updated: Book rental is a major part of school fees. Some fees are derived from workbooks, paperback books, practice sets, etc. which must be purchased outright. Textbooks are rented to students on a prorated basis to help minimize the costs to each student.

Textbook rental costs and all associated fees for the entire school year must be paid in full no later than October 3rd. Failure to pay by the deadline may automatically subject the responsible party to collections. The parent or guardian is responsible for paying any applied collection, attorney and/ or court fees.

Changes to a student's schedule could create a change in fees. Overpayments resulting from schedule changes will be refunded to the parent or guardian. If textbook rental fees are increased due to schedule changes, the payment is still due by October 3rd. Schedule changes after October 3rd that create an additional balance owed will be billed and payable upon receipt.
